General terms and information's		
1. Hine Adon has the right to do a control of the apartment at every time. 2. The reservation can be paid by day, week or month, but must be paid at least at the end of the month for the next month. 3. Every fee (guarantee, key deposit CHF 100.00, application fee CHF 100.00) must be paid before the arrival date. 4. A deposit of CHF 100.00 is levied per key, and will be returned at the check-out, when the key is given back. 5. A copy of the passport (or identity card) and a copy of the credit card as collateral. 6. The customer client agrees in case of premature departure, to pay the amount due, until the end of the contract. 7. The customer is responsible for the reservation and Hine Adon has the right to cancel the contract within 48 hours according to the law of froud hostel if payment terms and rules are not respected. 8. Any damage caused by the customer will be charged by Hine Adon and deducted from the reservation guarantee amount. 9. The guarantee will be returned only after the check-in/check-out report is considered to be in order. 10. The single rooms are for 1 person and the double room for 2 persons. 11. Hine Adon has the right to change the room/apartment and building if necessary. 12. Prostitution, abuse of alcohol, drugs and smoking are strictly forbidden under pain of immediate termination of the contract. 13. Hine Adon has the right to close the room and to charge to the costumer the change of the lock, if the monthly reservation is not paid, one month in advance. 14.
